# Draft MINUTES OF THE STEERING COMMITTEE

September 16, 2005, 9:30

#### 1. Introductions

Secretary George Nichol on vacation, John Headlee recorded and prepared meeting notes.

# 2. Executive Director's Report

This reporter entered while the second item, Dues, was being discussed...

Moved by KT Shum that dues become due at the beginning of the Forum's fiscal year

Seconded by Jay Lund

Motion carried without opposition

Discussion was had of a possible motion to establish a dues class for small and non-profit organizations with the suggestion that \$500 be the dues. Discussion was tabled.

Discussion of the need for an auditor of the forum's books was had. Lisa will check with SFEI and the Nature Conservancy to determine who audits their books.

# 3. Secretary's Report:

The May 20 and July  $5^{\rm th}$  Steering Committee meeting minutes were adopted in their entirety.

## 4. Treasurer's Report:

Lisa Holm's report revealed that there was a general fund balance of \$98,518.51 and a peer review fund balance of \$19,787.47. A total of \$70,100.00 was committed to the CALSIM II review.

5. Strategic Analysis Framework for Managing Water In California

Jay Lund reported that the Strategic Analysis framework is finished. Issue: Should CWEMF approve it as an *ad hoc* committee report? The main revisions were to Section V Road Map. A discussion ensued about databases and data review. To what extent would inconsistent data be reviewed? It was concluded that data objectives would be further defined. KT Shum thought the review would be in the nature of setting error bounds. Lloyd Peterson said USBR would fund database development by Jim Cornell of USBR.

Lloyd Peterson moved that the Strategic Report be accepted. Tara Smith seconded the motion and the motion passed without opposition

A discussion was then had as to who would take charge of mapping out the next steps of implementing the strategy. Marianne Guerin, Jim Cornell of USBR, Lloyd Peterson, KT Shum,Rich Satkowski and Tara Smith took on this task.

6. Jay Lund reported on the review of CalSim II for the San Joaquin Valley. Thirty major points that the review committee has agreed upon will be presented on the web. Public comments will be taken by email.

San Joaquin Modeling workshop will be held at the same location on November 4.

Lisa Holm reported that while working on drinking water she heard that Tetra Tech got approval to do a framework for TMDL modeling for the entire Central Valley. This bears looking into. She would like to collaborate with Tetra Tech on a workshop concerning groundwater, salt and nutrients.
